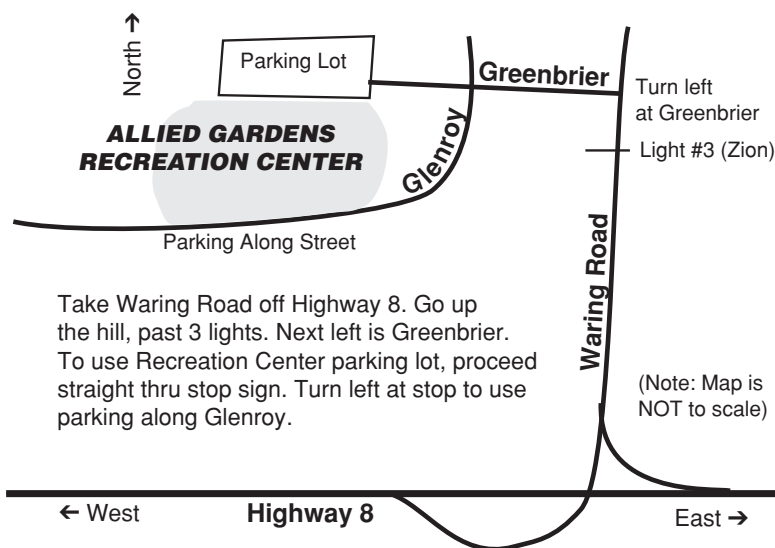

## **Unfamiliar with UKC Novice Rules?**

There are 2 main differences between AKC and UKC at the Novice level.

- 1) In UKC Novice, the dog must do a recall over a solid jump set at his shoulder height. A steward stands at each end of the jump while you call the dog.
- 2) There is no “group” long down exercise. Instead the dog does an “honor dog” exercise in which the dog maintains a down stay in the ring while the next dog in the ring does his heeling exercises. You stand across the ring from your dog as in the AKC long down.
